

MR LIAW WEI SHING – DIRECTOR

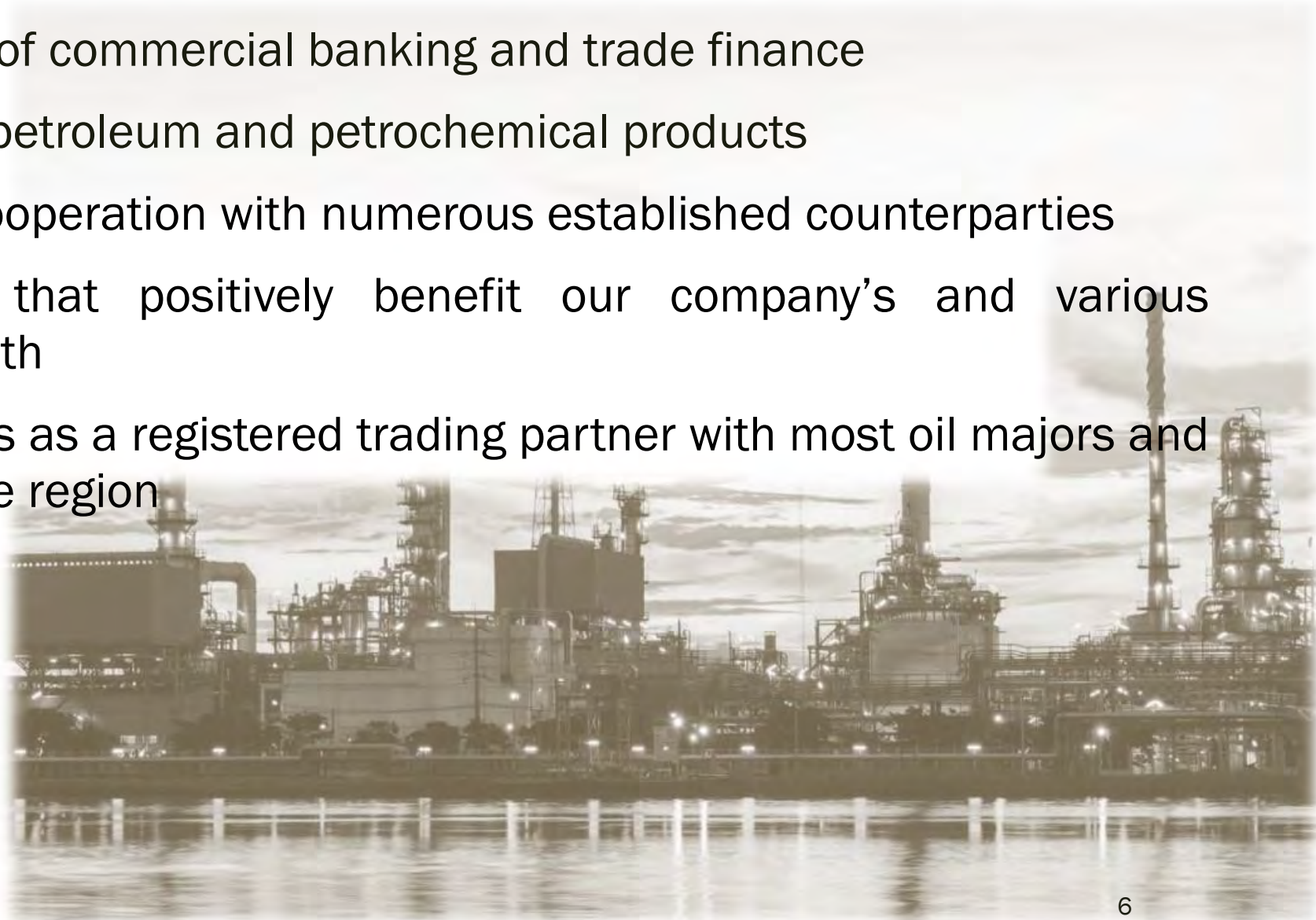

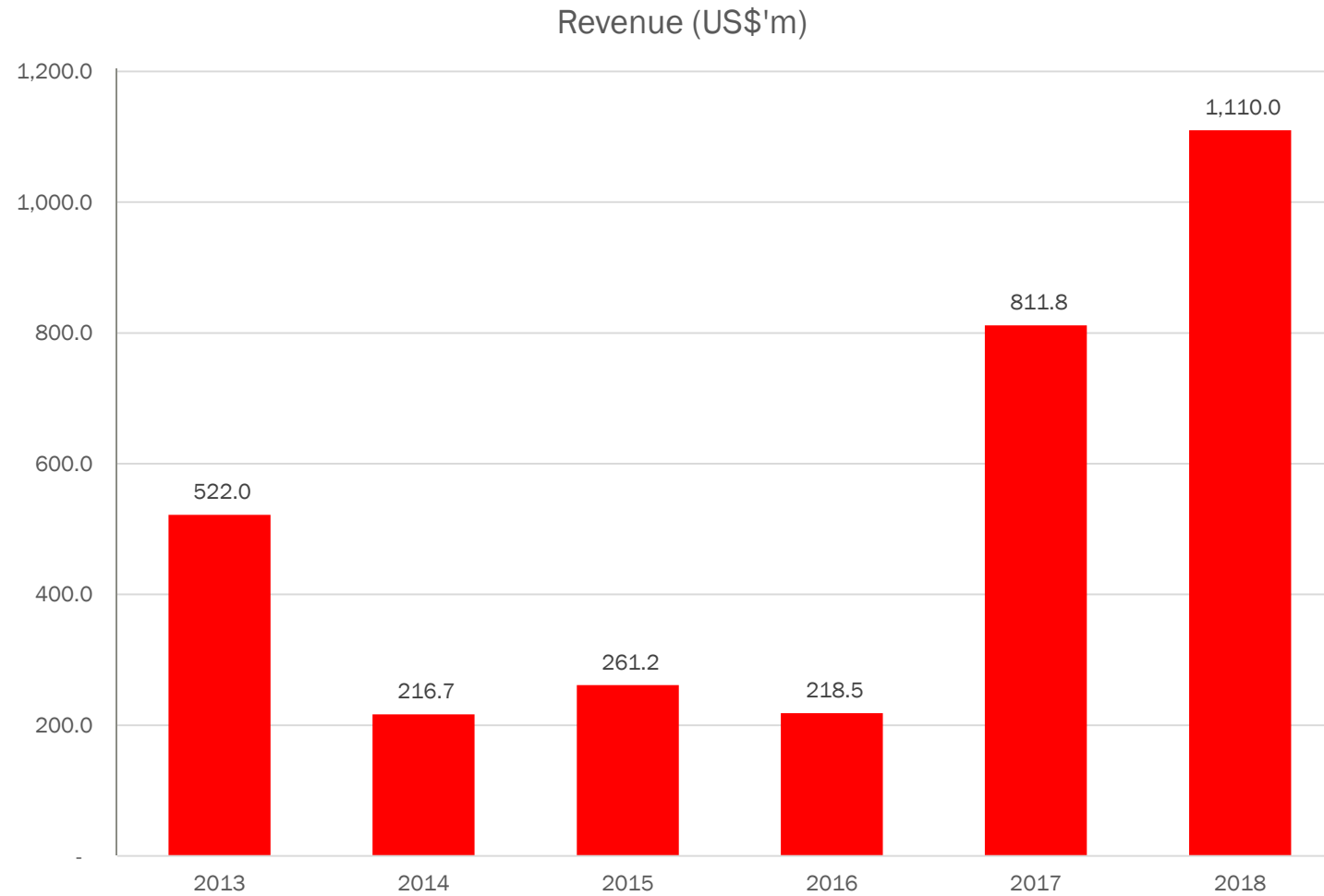

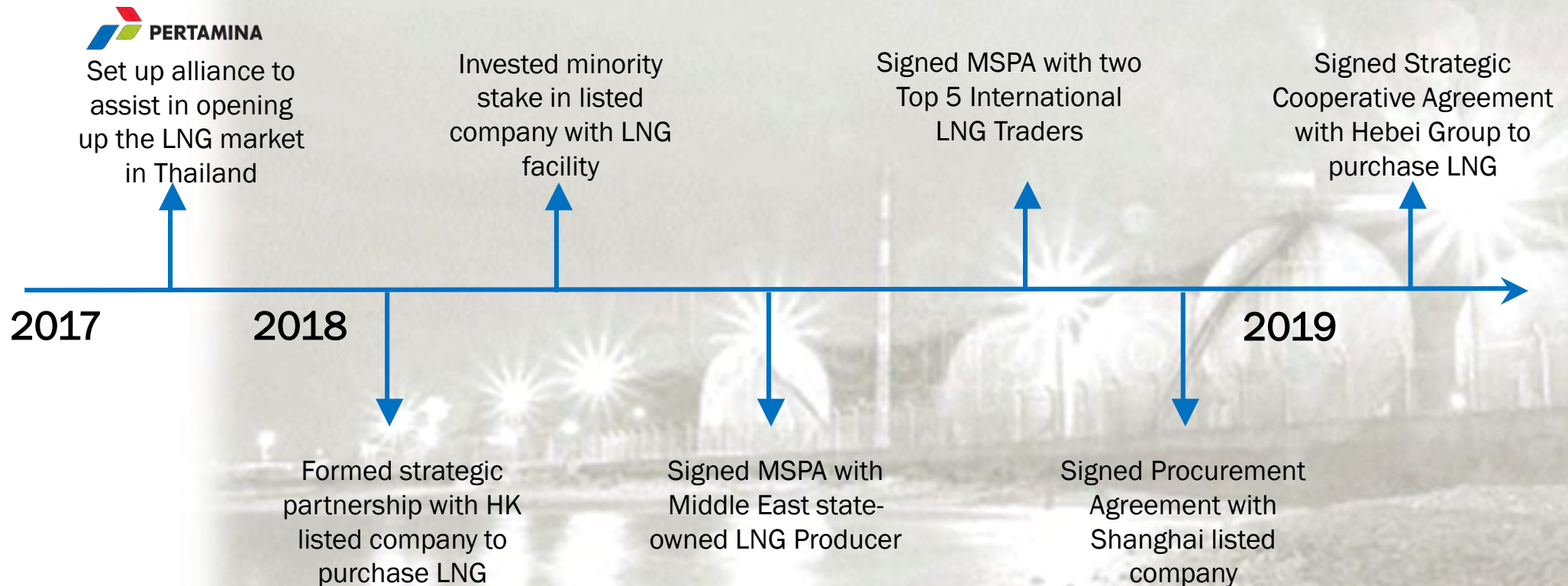
